



Dr. Gracita R. Arrindell, WGE

Dr. Gracita R. Arrindell was born in Curacao, Netherland Antilles from parents who hailed from St. Maarten. She holds a Masters Degree in Political Science and Public Administration from Radboud University. After her studies, she returned to St. Maarten where she held many political positions in the island government.

Among her many accomplishments, Dr. Arrindell was appointed the first female Chairperson for the Supervisory Board of Directors for the Princess Juliana International Airport. In 2003, she was elected to lead a new political party, the Peoples Progressive Alliance (“PPA”). During that same year, Dr. Arrindell became a member and Faction Leader on the Island Council. Dr. Arrindell is also founder of Peridot Foundation for the eradication of domestic violence among women and children, and founder of the Peoples Progressive Alliance Women’s League (“PPAWL”) which strives to celebrate the powerful strength in women.

She is the composer of the theme song for the National Youth Council of St. Vincent and the Grenadines. Empowering the youth with vision through her lyrics Ms. Robinson-Hazell has brought hope for the next generation.

Ms. Robinson-Hazell holds the positions of coordinator of the Caribbean Association for Feminist Research and Action (CAFRA) and of the Caribbean Gender and Trade Network. A Kellogg Fellow, Ms. Robinson has majored in International Development. She has wide experience in researching the social impact of trade agreements on Caribbean people and Caribbean women especially. She has also been actively involved in activities for the implementation of the Beijing Platform for Action at local, regional and global levels. Jane Ip, WGE was born in 1958 in Hong Kong and moved to Canada in the 1980s. After graduating with Psychology and Business Degrees from Portland State University in Oregon, in 1984, she obtained her MBA from York University. A year later, Jane started Jeanne Lottie with her sister, Charlotte, and used a combination of both their names together to give life to Jeanne Lottie.

Jeanne Lottie is a name synonymous with stylish, affordable and fun handbags distributed across Canada. Jane Ip, this dynamic entrepreneur, also has a perfume line which includes Diamond Rose and Pink Diamond exotic fragrances that evoke the "joie de vivre", the Spirit of True Happiness. The Jane Ip is a humanitarian whose company is actively involved in fundraising events for charitable causes. Jane is the founder and chair of The Pink Bedroom Party, a fun and glamorous lifestyle event raising money for the Campbell Family Institute for Breast Cancer Research for the Princess Margaret Hospital. Over six years ago, Jane Ip launched the fundraiser for cancer victims in her pink bedroom inside her Victorian Pink House. Hon. Stephanie Tubbs-Jones, WGE

The late Hon. Stephanie Tubbs-Jones, WGE was a native Clevelander. She attended Cleveland Public Schools and was a Major Work Program graduate. Congresswoman Tubbs Jones received both her Bachelor of Arts Degree in Social Work and her Juris Doctorate Degree from Case Western Reserve University. She received honorary doctorates from David N. Meyers University, Notre Dame College, Central State University and Cleveland State University.

Her entire career was spent in public service. She was an Assistant County Prosecutor, a Trial Lawyer at the Equal Employment Opportunity Commission, and was elected Judge for the Cleveland Municipal Court. Rep. Tubbs-Jones was the first African American woman to sit on the Common Pleas Court of the State of Ohio. She was the first African American woman to become the Cuyahoga County Prosecutor, and the first African-American woman to represent Ohio in the United States Congress. She served five terms in Congress where she continued breaking ground. Among her many accomplishments, she was also the Whip for Congresswoman Nancy Pelosi's Leadership Campaign, Co-Chair of the Democratic National Committee and the first African American woman to serve on the Ways & Means Committee. Rep. Tubbs-Jones was the Chairwoman for the Committee of Standards of Official Conduct (Ethics).



Dr. Rosemarie Wright-Pascoe

Dr. Rosemarie Wright-Pascoe, MBBS, DM, FRCP, FACP, FACE, WGE was born in Kingston, Jamaica. Dr. Wright-Pascoe is a graduate of the University of the West Indies, Mona Campus, where she earned a Bachelor of Medicine and Bachelor of Surgery (MBBS) degrees. Dr. Wright-Pascoe later entered the Doctor of Medicine (Internal Medicine) program. She has completed postgraduate work in Endocrinology and Metabolism at Tel-Aviv University and as a fellow at the University of Edinburgh (UK) under the Commonwealth Fellowship Program.

Dr. Wright-Pascoe is a senior lecturer, at the UWI, Mona. She has taught many medical students and postgraduate students in Medicine. She has contributed to the Science of Medicine more than fifty papers and abstracts published in peer-reviewed journals. Celia Catherine Zuckerman, known to her friends as Cat, is the President and Chief Executive Officer of New York Congregational Community Services which includes the Nursing Center, the Center for Community Life, and the Home for the Aged Foundation. At Congregational, she created the strategic plan and framework which allowed for the expansion and growth while developing a corporate identity and national recognition for service delivery. President Zuckerman is an awesome humanitarian and advocate for the elderly. Her affectionate disposition radiates dignity and love throughout the home centered facility in which she cares for her residents.

Her experience and successes include a completed \$8 million renovation and transformation of a landmark eligible building, while 50% occupied, into a modern, comfortable, and fully rented Center for Community Life, providing services for all ages - a model for the community. The Long Term Home Care Program was created to meet a very real community need while serving as yet another mechanism to insure corporate financial stability.

In her "second career" as an Executive in Long Term Care, Ms. Zuckerman has over twenty years experience in the field of continuing care services to the elderly living at home in the community; residing in varied levels of protected housing, with and without care services; and, residing in both residential long term care, Alzheimer's facilities and complex, Sub-Acute Nursing Facilities. Her experience includes the strategic re-direction of resources in four skilled nursing facilities which experienced deficits to realizing revenue enhancements, affecting a positive bottom line in each case. She has developed Alzheimer care models in Nursing Facilities and adapted these models in the creation of an Adult Day Health Center. In addition, she adapted these Alzheimer care models for assisted living and a continuing care retirement community.
